Each CWC company has a Master Development and Business Plan(s) prepared, incorporating multiuse, layered, opportunity zones, in order to protect these areas from encroaching development, whilst creating sustainable and conservation-based revenue streams for the local communities and other stakeholders.


### JAMES ARNOTT
